From the 1st January 2015 all students currently progressing through any of the following GSES courses must present selected personal information for mandatory Federal Government reporting:

- GSES Design and Install Grid Connect Photovoltaic (Solar Power) Systems
- GSES Install Only Grid Connect Photovoltaic Systems
- GSES Design Only Grid Connect Photovoltaic Systems

This information will be kept private and shall be used solely for mandatory government reporting for the purpose of generating training statistics for different regions of the vocational education sector.
